Study design	6	<p>For each experiment, give brief details of the study design including:</p> <p>a. The number of experimental and control groups.</p> <p>b. Any steps taken to minimise the effects of subjective bias when allocating animals to treatment (e.g. randomisation procedure) and when assessing results (e.g. if done, describe who was blinded and when).</p> <p>c. The experimental unit (e.g. a single animal, group or cage of animals).</p> <p>A time-line diagram or flow chart can be useful to illustrate how complex study designs were carried out.</p>	Methods, Page 4~7
Experimental procedures	7	<p>For each experiment and each experimental group, including controls, provide precise details of all procedures carried out. For example:</p> <p>a. Housing and husbandry	9	<p>Provide details of:</p> <ol style="list-style-type: none"> Housing (type of facility e.g. specific pathogen free [SPF]; type of cage or housing; bedding material; number of cage companions; tank shape and material etc. for fish). Husbandry conditions (e.g. breeding programme, light/dark cycle, temperature, quality of water etc for fish, type of food, access to food and water, environmental enrichment). Welfare-related assessments and interventions that were carried out prior to, during, or after the experiment. 	Page 6, Paragraph 3
Sample size	10	<ol style="list-style-type: none"> Specify the total number of animals used in each experiment, and the number of animals in each experimental group. Explain how the number of animals was arrived at. Provide details of any sample size calculation used. Indicate the number of independent replications of each experiment, if relevant. Allocating animals to experimental groups	11	<ol style="list-style-type: none"> Give full details of how animals were allocated to experimental groups, including randomisation or matching if done. Describe the order in which the animals in the different experimental groups were treated and assessed. 	Page 6, Paragraph 2
Experimental outcomes	12	Clearly define the primary and secondary experimental outcomes assessed (e.g. cell death, molecular markers, behavioural changes).	Page 7, Paragraph 9-10
Statistical methods	13	<ol style="list-style-type: none"> Provide details of the statistical methods used for each analysis. Specify the unit of analysis for each dataset (e.g. single animal, group of animals, single neuron). Describe any methods used to assess whether the data met the assumptions of the statistical approach. 	Page 7, Paragraph 6

Baseline data	14	For each experimental group, report relevant characteristics and health status of animals (e.g. weight, microbiological status, and drug or test naïve) prior to treatment or testing. (This information can often be tabulated).	Page 8, Paragraph 3
Numbers analysed	15	<ol style="list-style-type: none"> Report the number of animals in each group included in each analysis. Report absolute numbers (e.g. 10/20, not 50%²). If any animals or data were not included in the analysis, explain why. 	Page 8, Paragraph 5

Describe any implications of your experimental methods or findings for the replacement, refinement or reduction (the 3Rs) of the use of animals in research. Generalisability/translation	19	Comment on whether, and how, the findings of this study are likely to translate to other species or systems, including any relevance to human biology.	Conclusion, Page 12, Paragraph 5
Funding	20	List all funding sources (including grant number) and the role of the funder(s) in the study.	Declarations, Page 13, Paragraph 14
