29. Quotations presented	Were participant quotations presented to illustrate the themes/findings? Was each quotation identified? e.g. participant number	18-28, Results
30. Data and findings consistent	Was there consistency between the data presented and the findings?	28-33, Discussion
31. Clarity of major themes	Were major themes clearly presented in the findings?	18-28, Results
32. Clarity of minor themes	Is there a description of diverse cases or discussion of minor themes?	18-28, Results
